

# Ultimate Hockey Fan Sweepstakes

## OFFICIAL RULES

### NO PURCHASE NECESSARY

#### OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (D.C.), 18 YEARS OF AGE OR OLDER ONLY
